

#### Message from you local Inspector, Ed Brown

There have been no significant incidents in the last month. As a result of positive media reports in the Quay magazine there has been good attendance at the Police station during opening times to meet the local beat manager, Pc Jason Pegden. The next open day at the Police station is on 26th March. There has been an increase in reports of Hare coursing across the area and liaison has continued with local landowners. The use of FastSMS will continue to be used to give real time information regarding incidents and vehicles to look for. Additional patrols have been conducted utilising the Police drone which has assisted in targeting and patrolling the larger rural areas. As the weather begins to improve it is a good time to remind people of the need to protect against outboard thefts and all local boat yards will continue to receive visits. The next rural crime meeting with Chief Constable Bailey and PCC Green is on 11th March at Holkham.

## Crime Updates (1st to 29th February 2020)

Offence	Numbers	What could this entail
Arson	0	Damage caused as a result of fire.
Anti-Social Behaviour (ASB)	0	Harassment, alarm or distress is caused in a non-crime incident.
Burglary - Residential	0	Entry and theft to any building within the curtilage/boundary of a residence.
Burglary - Business and Community	0	Entry and theft to any building or structure not within the curtilage/ boundary of a residence.
Criminal Damage	0	A person destroys or damages property belonging to someone else.
Domestic	0	Domestic incidents where a crime has not occurred. Parties are aged 16 or over and have been intimate partners or family members regardless of sexuality.
Hate Incident	0	Any incident where a crime has not occurred which the victim, or anyone else, thinks is based on someone's prejudice towards them because of their race, religion, sexual orientation, disability or because they are transgender.
Race or Religious aggravated public fear	0	Any crime determined to have a hate element as per above.
Possession of controlled substance	0	Unlawful possession of a drug classified in class A, B or C.
Possession of weapons	0	Unlawful possession of an article used as a weapon.
Public fear, alarm or distress	0	Public order offences e.g. from a verbal altercation to offences just short of violence.
Robbery	0	Includes a range of offences where force is used, threatened or the victim is put in fear.
Theft from a motor vehicle	0	Any item stolen that was in, on or attached to a motor vehicle.
Theft or unauthorised taking of a motor vehicle	0	Any motor vehicle including those abandoned.
Theft of pedal cycle	0	From a public place, if stolen from a shed or garage this would be a Burglary Residential.
Theft from a person	0	Purse being taken from a handbag, or a mobile phone from a shopping basket.
